**Regulations of
Traditional MMA Tournament:
Cup of the Northern Capital
Among Juniors (18-20 years old)
2018**

St.Petersburg, 2018



Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) is carried out in accordance with the rules and requirements of the World MMA Association.

Individual-team competitions are held in 8 weight classes for men among juniors with team classification among the participating countries.

I. GOALS AND OBJECTIVES

- Determination of the strongest sportsmen and teams in the World;
- Development and promotion of Mixed Martial Arts (MMA) worldwide;
- Improvement of judges and coaches qualification and sportsmen's level of training;
- Involvement of different groups of people in active lifestyle;
- Expansion of cooperation in the sphere of development of MMA in the world.

II. PLACE AND DATES OF COMPETITION

Preparation for the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) is carried out by Organizing Committee. The Judges committee is directly responsible for the competitions.

The Presiding Judge of the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) is /TBA/;
The Deputy of the Presiding Judge is Svetlana Grozina (Russia).



IV. COMPETITION APPLICATION, REQUIREMENTS TO PARTICIPANTS AND CONDITIONS OF THEIR ADMISSION

The following athletes are admitted:

- Juniors (male) 18-20 years old (those who hasn't turned 21). on the day of the event).

Admission will be controlled by the Credentials Committee of the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old).

Preliminary applications to participate in Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) are submitted to the organizing committee not later than February 23, 2018.

Participating team consists of max. 10 people:

Juniors 18-20 – 8 athletes (1 per each weight class):

Male: -56,7 kg, -61,2 kg, - 65,8 kg, - 70,3 kg, - 77,1 kg, - 84 kg, - 93 kg. +93 kg.

Coach / Team Representative - 2 ppl.

The following documents shall be provided to the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) Credentials Committee:

Credentials Committee has the authority to review the applications and either approve or disapprove the admission.

- Application in a standard form from the National Federation with obligatory presence of duly sealed signatures of the Head of Federation, Coach and Doctor;

- Identification documents;
- A completed competitor's card with acknowledgement (Annex No. 1,2,3)
- Certificates on HIV and Hepatitis B and C (originals).
- Health insurance policy and insurance contract (original) for this competition;
- Participation permission from parents for the particular event (original).
- National anthem on the CD or a USB-drive, national flag.

In order to have equal starting opportunities for sportsmen the Panel of Judges is entitled to demand the participants to undergo doping control procedures during or after the competitions. Where a participant or team representative refuses to undergo doping control procedures the participating team is not allowed to compete and is disqualified.



V. COMPETITION UNIFORM AND EQUIPMENT OF SPORTSMEN

According to the Rules of the competition, sportsmen must wear long or short fight shorts and use protective equipment for men:

- white open - finger gloves of at least 5 ounces (blue or red tape or plaster shall be wound around the wrist);
- protective mouth piece for teeth;
- bandage to protect the groin;
- shin guards.
- Helmet.

Sportsmen compete without shoes.

VI. COMPETITION PROGRAM

Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) is held on March 24-25, 2018 in St. Petersburg, Russia, 80/1 Primorskiy prospect, M-1 Arena.

March 23:

14:00-23:00 – arrival and accommodation of the participants;

17:00-23:00 – credentials committee.

March 24:

07:00-08:00 – weigh-ins and medical examination (in the host hotel);

08:00-09:00 – breakfast (in the host hotel);

09:30 – departure to the venue;

11:00- preliminary bouts;

13:00 – opening ceremony.

March 25:

13:30 – lunch (in the host hotel);

15:00 - departure to the venue;

16:00 – Opening ceremony of the Finals;

17:00 – final bouts and awarding ceremony.



March 26:

Before 12:00 - departure of competition participants.

VII. REGULATION OF THE BOUTS

The Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) is held by the Olympic system. All bouts are held with 2 rounds 3 minutes each (60 sec break between the rounds).

The winner is determined in accordance with the Rules of Competition approved by WMMAA.

VIII. SUMMING UP

Individual-team competitions, they are held in accordance with the “Official Rules of Mixed Martial Arts Competitions” approved by the WMMAA.

Team placing is determined by the maximum amount of points in individual classification of team members:

1st place	10 points
2nd place	8 points
3rd place	6 points
5th place	4 points
6th place	3 points
7th place	2 points

5th place is taken by the participant, who lost to the champion in the quarter finals, 6th place is taken by the participant, who lost to silver medalist in the quarter finals and 7th place is taken by the participant, who lost to bronze medalist.

IX. AWARDING OF WINNERS

Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) winners in individual competition and prizewinners of the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old) who took 2-nd and 3-d places in individual competitions are awarded



with medals, diplomas and special prizes. Teams taken 1, 2 and 3 places are awarded with cups and diplomas.

X. FINANCING TERMS

The following financial, material and technical commitments are imposed to the organizers and partners of the Traditional MMA Tournament: Cup of the Northern Capital Among Juniors (18-20 years old):

- to secure arrival, accommodation, meals and departure as well as guaranteed payment to the international judges' board and referees;
- to organize local transportation for all the participants from the hotel to the venue and back;
- to organize weigh-in procedure and Credentials committee, deliver all the contestants and their team members to and from the weigh-ins procedure (if needed);
- to provide medical surveillance at the tournament (AT LEAST 2 EMERGENCY CARS, 2 TEAMS OF SPORTS DOCTORS or PEDIATRISTS, 1 REANIMATION CAR);
- to ensure security of all the participants;
- to rent the venue for 2 days;
- to provide at least 1 fighting ring and all the required equipment;
- to award winners with prizes, gifts and other rewards in accordance with Provisions;
- to provide photo- and video –recording and presentation of materials to WMMAA executive committee;
- to provide microphones and other necessary sound and light equipment.

The following financial, material and technical commitments are imposed to the National Federations (at their own expense):

- Entry fee: 50 EUR per person (including coaches and representatives).

Entry fee includes accommodation in the host hotel for the period of the Tournament and breakfast:

- Transfer from airport/railway station to the hotel and back;
- Entry documents (visas);

XI. APPLICATION FOR PARTICIPATION IN COMPETITIONS

Applications for participation in competition shall be executed in accordance with the Rules of Competitions in two copies and submitted **not later than February 23, 2018.**

All participants should be registered in **SportID system by February 23, 2018.**

Teams must arrive to St.Petersburg for registration on **March 23, 2018 before 23.00.**
